Eligibility Statistics

The VCF has issued decisions on 7,909 claims, over 86% of the eligibility claims that are ready for decision.¹ Of the 16,449 Eligibility Forms that have been submitted, 7,314 claims (44%) cannot be decided at this time because they either (i) do not contain a signed authorization giving the VCF legal authority to process the claim or (ii) are missing other information needed to establish eligibility. When required information is missing from a claim, the VCF will notify the claimant or his or her attorney that information is missing from the claim and provide guidance on obtaining and submitting the required information. Among the total Eligibility Forms submitted to date, 14,251 claimants (87%) are represented by attorneys.

Of the 9,111 claims that are ready for review, 7,885 claims (86%) have been found eligible. The remaining 1,226 claims (13%) are currently under review to confirm that all statutory requirements have been met.

The tables below and on the next page show the status of Eligibility Forms received. Table 1 has been updated from the last status report to include information by type of claim form filed – Personal Injury Eligibility Forms and Eligibility Forms for Deceased Individuals. Eligibility Forms for Deceased Individuals includes only those claimants who died of causes directly related to their 9/11 eligible condition.

¹ The VCF cannot take action on a claim until the following requirements are met: (1) an Eligibility Form is submitted; (2) properly signed authorizations are submitted to allow the VCF to obtain and review information specific to the claim; and (3) the claimant has at least one eligible condition verified by the WTC Health Program either through direct treatment by the WTC Health Program or by providing required information from a treating physician outside of the WTC Health Program (or the claimant has a traumatic injury or an injury that was recognized as eligible in VCF1).



Table 2 provides additional information on the categories of conditions associated with the “Eligibility Claims That Can be Decided.” The breakdowns are based on conditions certified by the WTC Health Program.

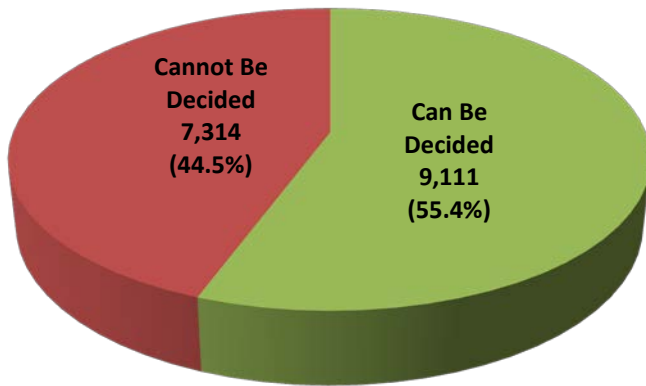

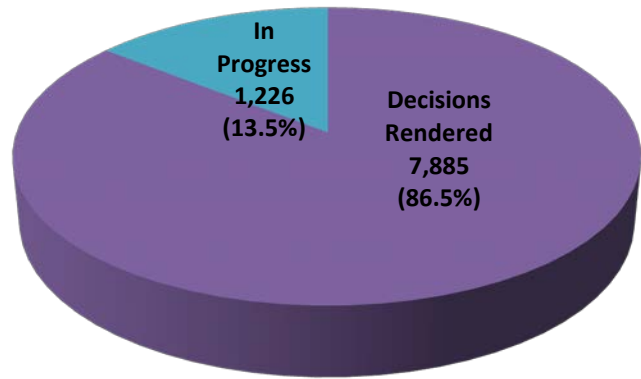
Status of Eligibility Forms Received

Compensation Statistics

Once a claimant is deemed eligible, the VCF begins review of the claimant’s Compensation Form to determine how much compensation the claimant is entitled to receive from the Fund. So far, the VCF has received Compensation Forms for approximately half of the claims that have been found eligible. As with the Eligibility Form, the VCF is not able to take action on a claimant’s Compensation Form without a signed authorization. Of the 6,626 total Compensation Forms received, 4,556 (69%) are for claimants who have been deemed eligible. Of those with eligibility approved, 3,118 (68%) have the signature documents and supporting information that is necessary to begin review. The remaining claims cannot be reviewed at this time either because they are missing the required signed authorization or other required information. When required information is missing from a claim, the VCF will notify the claimant or his or her attorney that information is missing from the claim and provide guidance on obtaining and submitting the required information.

Among claims with submitted documentation, the VCF has issued decisions on 1,843 claims (59%). The remaining 1,275 are under review to determine whether the submitted documentation is sufficient to calculate compensation. Only when the VCF has received the necessary documentation, which includes documentation regarding the claimant’s work capacity, compensation history, and relevant pension and other benefits, can the VCF calculate the appropriate compensation.



The tables below show the status of Compensation Forms received and decisions by category of eligible conditions. Statistics for Claims for Deceased Individuals includes only those claimants who died of causes directly related to their 9/11 eligible condition.

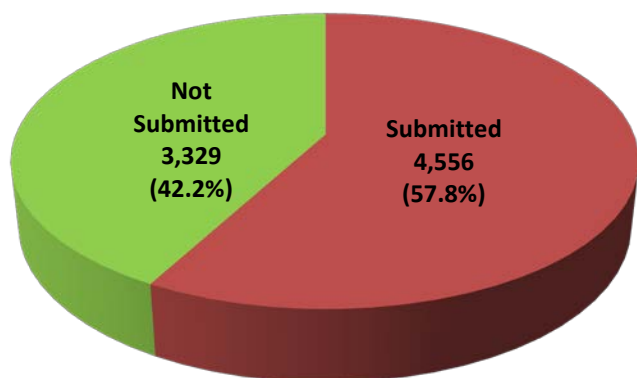

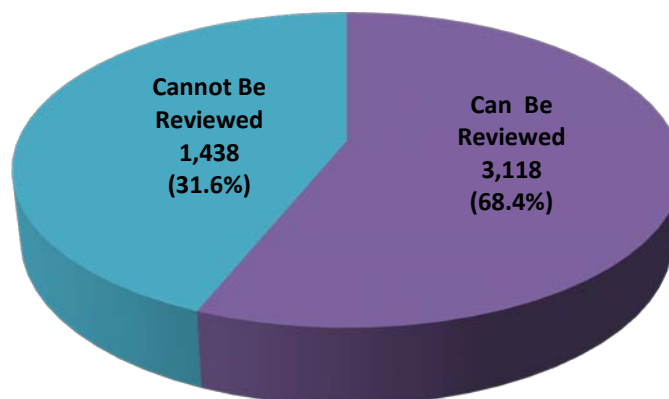

Registration Information

In order to allow potential claimants to meet the deadlines established in the Zadroga Act even if they are uncertain whether they will eventually file a claim, the VCF allows individuals an opportunity to “register” with the Fund, thereby preserving the right to file a claim any time before the VCF closes to submissions on October 3, 2016. Registration does not create an obligation or commitment to file a claim, and the Special Master expects that a large percentage of registrations will not result in claims being filed as they are either duplicates or were created by individuals who will eventually decide not to file a claim. The table below shows the registration data. The number of Interim Registrations is applicable only to the October 3, 2013, filing deadline and therefore has not changed since the last report was published on July 3, 2014.
